CHEMPLAST AWARDS

ChemPlast Awards are designed to recognize the work, leadership and transformation of those companies from chemical and plastics sectors that invest in innovation, sustainability and digitisation, focusing on all areas of business management: new products, equipment, processes, quality, technology...



CATEGORIES TO AWARD

The proposals that will be considered and accepted to participate in these awards must respond to the following categories:

- A. Industrial leadership in the use of sustainable technologies and processes.**
- B. Best business initiative to face the challenge of the fourth industrial revolution.**
- C. Best technological innovation for the development of new materials.**
- D. Best research project for the industry.**
- E. Best innovation for analytical technologies and quality control.**

TERMS:

- * For categories A and B, it will be necessary to prove that the technologies or initiatives proposed for the prize have been implemented.
- * To have the chance to win the category D, projects must have been finished during 2017 or the first semester of 2018.
- * The jury reserves the right to redirect a candidacy to another category if it is considered appropriate.

HOW CAN I PARTICIPATE



ChemPlast Awards are aimed at all companies, universities, providers, professionals, researchers, analysts, start-ups, or technological centre from all over the world who, invest in innovation and improvement in processes.

The mission of these awards is to encourage and promote innovation in the chemical and plastics industries. Any organization can opt for these awards, as long as they testify to their candidacy. To submit your candidacy to the **ChemPlast Awards**, please fill in the information in the [online form](#). Proposals must be submitted electronically through this web page and the terms and conditions included in the form must be accepted.

The form and all the complementary information that is delivered must be in Spanish or English. (Proposals in other languages will not be accepted).

No additional documents will be accepted to the form unless required by the organization. The organization reserves the right to request any clarification or additional information on the submitted proposals.

All registrations must be submitted **before October 5th, 2018**.

EVALUATION & SELECTION



Competing proposals will be evaluated by our Steering Committee in terms of:

- Innovation
- Leadership
- Disruption
- Strategy

The evaluation process is divided into two phases:

PHASE 1:

Regulation compliance and pre-selection: the organization and a Technical Committee of experts will conduct the first evaluation to check whether the proposal complies with the requirements and selection criteria defined.

The evaluation process will be held by the members of the Steering International Committee individually, with the aim of selecting the finalists of each category.

If needed and exceptionally, the organization will ask for complementary information to the candidate's proposal.

PHASE 2:

Selection of winners: the International Committee of Experts will meet the days prior to the celebration of **the Delivery Gala (Which will take place on Wednesday, November 7 in Madrid)**, evaluate the finalist projects and select the winner of each of the categories.

Any prize award category could be declared void by the International Committee.

Pre-selected candidates will be informed before October, 20th 2018.

PRIZES



ChemPlast Awards will award the winners with the following prizes:

- A single invitation to attend the Awards Gala Dinner for each of the finalists of each category.
- Delivery of the award of the prize won and the corresponding category, for the winner of each category.
- Dissemination of each of the awards to all general and specialized media accredited in ChemPlast.

INTELLECTUAL AND INDUSTRIAL PROPERTY RIGHTS
